Thank you, everyone for joining us. Today, I will hold off and let us get our screen shared first, however, thank you Kira.

So what's really exciting about accessibility and accessibility practices is that it makes sure that your work reaches a broader audience, that it reaches more people and that more people can engage with you. And so a really important thing to do to make sure that your work ends up being shared with as many people as possible is preparing your presentation for it to be as accessible as possible. And so this includes three specific things to do. One, create access copies and or an outline, to develop a list of key terms. And three, make sure that your PowerPoint formatting is done in an accessible manner so that your access copies are actually accessible access copies. So I'm going to start with that first point on access copies and or outlines. Access copies are basically anything that you plan on sharing with your audiences, through screen share, such as this will need to be shared in a PDF, Word document or PowerPoint, so that people can download it and view it at their own time and at their own pace. This is really important for so many people with different access needs, it's important to help people prepare, so they can follow what you are saying before they join your session. It can help people during the session who like to kind of switch between slides to get a sense of what's coming next, or what was was happening just a moment ago. It can also be really helpful for people afterwards, so they can review it afterwards. And the outline, if you're not going to present via

PowerPoint, for example, an outline is a great alternative to that. So that way people can know kind of what you're planning on talking about during your presentation during your session, and know where you're at. So if, for example, they aren't focused for a moment for any reason, I mean, it can be disability related, it can be related to pandemic working conditions in which we're living in our houses with the people we with lots of people and animals around us who may distract us.

And so these these are really universal applications unhelpful for a large amount of people, even if they're primarily developed for people with access needs, who have access needs related to disabilities.

And so those outlines can be just a quick 123, I'm going to talk about these three points. Those access copies might be handouts that you would have given in an in person meeting, it might be the PowerPoint itself.

And those access copies you will want to make sure are made in an accessible way, which means that the contrast is high contrast. So nobody's going to struggle with reading those access copies that

if it's a PDF, that the PDF is screen reader friendly, and so forth. So that's kind of point one. And it's also just really helpful. It helps me to kind of gather my thoughts before I show up and present. So it's both for your audience but it can hopefully help you out too. And just make sure that everybody is on the same page. Do

and then so the next point is a list of key terms. This is helpful for two reasons. It is especially important if you are working with cart captioners, professional captioners who are typing what you are saying and may not have jargon or proper nouns or any thing related to that in their automatic dictionary on their cart captioning keyboard, or ASL interpreters. One of the jokes about

trying to prepare these key terms is that imagine trying to kind of sign some of the jargon that we use as anthropologists. Even the word hegemonic, right, it's it's pretty natural to a lot of us. But

a lot of the words we use naturally within the field and discipline, don't have sign equivalents in American Sign Language, don't have them automatically included in the cart captioning keyboards, which are different from the keyboards we use the QWERTY style keyboards that most of us use. So this list of key terms is really supportive of cart captioners and ASL interpreters, and can also be helpful for people who may be learning some of the jargon who are interested in your topic who want to learn more about your topic, but may have never heard these terms, and it helps them follow along as well.

So with those key terms, it's an issue of ensuring that you include names

any titles, so for example, when I create a list of key terms, I always ensure that my name is included that my title as the accessibility and meetings manager is included, that my association name is included American Anthropological Association, and any terms that I might be switching into or using, or if I plan on switching to another language, in my case, Polish, I identify that I will speak Polish that I will say I'm about to speak Polish, so the for cart captioner can input into parentheses speaking Polish cannot caption

so that the ASL interpreter is ready for that, or if I plan on using specific terms from the Polish language, I include those and provide kind of phonetic explanation. So ideally, the cart captioner can caption those alongside as well.

Um, so that's point two. And then point three is on PowerPoint formatting. With regard to PowerPoint formatting, you really want to make sure that your PowerPoint is

basically really easy to follow along with that it's not too distracting, that it doesn't have bright colors that can be really distracting or can actually

you want to make sure that the contrast is high enough, so nobody has eyestrain, because they're trying to like read light green font on barely light, darker green background.

- simple and to the point so that way people can follow along. And ideally avoid long

Or if you plan on using those long paragraphs of text, making sure that you don't go below a certain point, font size, which is that 18 point, size.

And importantly, with PowerPoint formatting, if you format it in advance, especially with Microsoft PowerPoint, and do an accessibility check. So if you put Accessibility Checker or just write accessibility and the Microsoft search engine, on your PowerPoint

program, and the same applies to word even, then it will tell you everything you need to fix and it will tell you how to fix it. And the minute you fix it is the minute you can print it as a PDF and you are far closer to having an accessible PDF,

basically, doing these checks of the documents you've created beforehand will make sure that your presentation is as accessible as possible and that your attendees and your audience members can engage with what you're talking about in a really helpful and meaningful way. Because they can follow an outline, they can follow the access copy, they will have the ability to access the access copy because it's screen reader friendly.

They have lists of terms and the ASL interpreters and cart captioners have that list of terms.

Great, thanks. Now, this is curious speaking. So I am going to speak twice tonight, the first portion of what I'm going to review is going to be the zoom processes that we're going to ask livestream presenters to follow, as well as what your session is going to look like in huva. And how attendees will interact with your session on that end. And then at the end, I'm going to review some of the upcoming studies that we're going to take in terms of submitting supplementary materials, get access to who's sending out zoom links, things like that. So without further ado, I'll go ahead and jump in.

Let's see, can I get out of this great. So I wanted to bring your attention to the live stream presenter guide. This is a guide that we have put together, which covers most of what we're going to be reviewing today, in a little bit greater detail, it can be found on the applied anthro website, if you head to the presenter training webinar area. And then underneath live stream presentations, you can access that live stream presenter guide. When the training are finished, we are going to upload the recordings here. So you'll be able to come back and watch as well as access the transcripts for the sessions. So just wanted to point that out. Before we get started on the live stream presenter guide. To start, we have some things that we are recommending you double check before you actually engage in your live session. These include camera microphone, audio tests, screen sharing tests, internet tests, things of that nature. Rebecca, Eli's going to go into a little bit more detail later on. But I wanted to bring your attention to some of the things we hope you can ensure are working properly before you actually log into your session. So next, I'm going to review the live stream process. So we have, I think, 131 live stream sessions, about 90 of those are going to be conducted as webinars. And I think about 45 are going to be conducted as meetings. And so I'll explain the difference between the webinar and the meeting format. But regardless of the format, all of the live stream presenters have, we're asking that you follow this process. So first, we hope that you can log in 15 to 20 minutes early before your presentation begins. So if you're at the 10am slot, we're asking that you log in at about 949 45 if you're out the 12pm 1140 1145, and so on. The reason we're asking for this is so we can ensure that all of your technology is working properly before the session starts. So what's going to happen when you log in is an SFA representative is going to start the meeting on our end. And these are going to be for all of the sessions run through the zoom, excuse me the SFAs zoom license. So we are going to go ahead and start the meeting on our end. And then we're going to hand the host controls over to a

moderator. When I use the term moderator, I'm referring to a technical and security moderator, not the session chair. So all of our live sessions have been assigned moderators. And I'll touch on them a little bit more in the next slide. Once the moderators have control of the meeting, they are going to perform that tech check with you. So we're going to check that your audio and your video is working properly, we're going to check that you have the ability to share your screen if you're going to share any of those materials. So we just want to make sure we can get all of that done before the session starts. So once the session does start, we can just hit the ground running and engage in that presentation.

All of the sessions are going to be automatically recorded. So neither the moderator or the session chair or presenters need to worry about the recording that will be automatically uploaded to our sfaa Cloud, the zoom cloud, where we are going to process it and get that re uploaded into huva within a week. So if anyone missed your live presentation, they can come in and actually watch it about a week or two after no promises on how quickly we can get that done.

After after the technology check is set to go the session is ready to start. We're going to ask moderators to provide a very brief one to two minute introduction, where they essentially introduce themselves as the tech and security moderator and point out some of the functionality of zoom, where you can find chat, where you can mute yourself and things of that nature. And so that'll be very short and then once they hand that moderator hands off the presentation to the session chair, your presentation can proceed as much as

So as I mentioned, moderators have been assigned for all of the live sessions. I know many of you have actually signed up to moderate sessions yourself. So thank you, thank you. We are relying on volunteer moderation support to make sure we have a safe and accessible and welcoming meeting. So we really appreciate everyone who has been able

to do that and has volunteered for that. So moderators are going to handle any tech issues and any security issues that arise. We are currently working on that process. And so some of those details are going to follow along. But rest assured, we have processes in place to ensure that all of the meetings run smoothly, and we can prevent or reduce as many disruptions as possible.

So into the nitty gritty of webinars, first meetings, I just want to touch on some of the features of webinars verse meetings, and how it's going to change the way that presenters in these sessions interact with attendees. So as I mentioned, most of the sessions are webinars, and so webinars are going to run very similarly, basically identically to what we're in right now. So as you'll see, there's a handful of panelists and presenters on the screen, and all of the attendees are not able to share their video or their audio. This is a slight drawback, but we wanted to ensure it was a safe meeting and using the webinar format greatly reduces that zoom bombing risk. So

all of the live meetings, both webinars, and the zoom meetings are accompanied by a live channel meetup immediately following the live zoom session. So the sessions that run at 10am will be finished at 11:45am. At 11:45am, all of those session presenters and attendees can head over to a live channel meetup, where they can have live discussion and some of that back and forth communication that you might be missing in the webinar. I'm going to review what that process looks like in a moment. But let's say your presentation ends early. So you haven't quite reached the 105 minute mark, you want to go ahead and enable some communication with attendees back and forth. In webinars, there's going to be two main ways to do that. The first is going to be the zoom chat. So that chat feature most of us are familiar with is going to be enabled in those webinars. People can add comments, people can ask questions,

and presenters and the moderator can essentially read those off and answer those one by one. The other feature in webinars is the hand raising feature. So attendees can actually raise their hand and say, Excuse me, my cats meowing in the background.



So as presenters or excuse me, attendees can essentially Yes, sorry, I'm so sorry. Um, attendees can essentially raise their hand and moderators or the presenters will see that hand raised in the participant list, and the moderator can then unmute that participant. So if that attendee would like to ask a question, or, you know, make a comment they can do so the moderator will then mute them again, and the presenters can respond. So we have some instructions in the live stream presenter guide for communicating with your moderator to make sure you have a process established if you want to enable that back and forth forth communication in the webinar before you move to the live meetup area. Now, for meetings, meetings also have a live meetup area that they can use after However, because there's more back and forth communication. This is, you know, the meetings that we're all used to everyone's audio and video can be enabled, people can chime in as they please, you don't necessarily need to move out of that into the channel meetup. Because you'll have that back and forth communication. So it's really up to you. If you're at about 105 minute mark, and you're having some lively, ongoing discussion.

And the moderators will also be there to help in case you need to mute any participants or unmute participants, or if there's any disruptions going on. So those are the two big differences between the webinars and the meetings. And I'm happy to review that a little bit in more detail or answer any questions about that.

So I'm going to switch to our Hoover window so you can see the way so you can get an idea of what a session is going to look like. So here we have all of our sessions loaded. Very exciting. This is what a session will look like. So if we can pretend this as a zoom meeting instead of a pre recorded video, you'll see that the zoom meeting actually opens within the huva window. And members also have the ability to open this is their full screen. So during the meeting, we're recommending that all members, excuse me, all attendees and presenters use the Zoom chat during the meeting. And then they use the huva chat and g&a either before and after the meeting. The reason we have these different areas is the chat and the q&a and huva is going to extend for the length of the meeting. So these are questions that are going to hold in this area and people we will be able to see them no matter what day they log in, whereas the zoom chat during the actual meeting is not going to be saved. So if it's during the meeting, we recommend engaging in this zoom chat, chat area. And if it's after or before the meeting, we recommend directing your questions and your chats to the who the area, we are going to have a PowerPoint slide that all of the moderators can show at the beginning of each live stream session, it's going to look very similar, if not identical to this, where it just describes the difference. So again, the zoom chat function can be found typically at the bottom of your zoom window. That's what members are attendees can use to communicate with you during the actual live stream session. And the huva chat and q&a function, which is found on that right hand side of your session window is what they can use to ask questions or make comments after the session is over. Or if they're watching the recording a week or two after your sessions taken place. So just want to describe the difference between those. And then I'm going to head back into huva. So you can see what that session looks like again. So if we're pretending This is a live stream session, the live stream is going to open up directly in this window at the dedicated time. So at 10am. If your sessions at 10am, the live stream is going to go ahead and start here. attendees can log in, they can either have two options, they can watch it again in this window, or they can create a full screen zoom meeting as they would with a normal zoom meeting. Down below, we see some details, including the speakers as well as their abstracts. And then on the right, we have the chat and q&a area, as well as a poll area. So presenters can create polls for their sessions. And so polls give you a few different options, multiple choice checkbox short answer different selections you can create a poll with. And you also have an option to prompt attendees to answer the poll when they enter your session. So if you'd like to get some, you know, communication back and forth with attendees through polls, you can do that. You also have the option to not prompt if you just want to leave it optional for attendees.

All right, let me head back to the agenda for a moment.



So as I mentioned, all of the live stream sessions are going to be in channels. And so we have five channels at any one given time. So at 10am, you have channels 1234 and 5:12pm. You have the five channels, 2pm, so on and so forth. So each of these channels, whether it's a webinar or a live stream, after the session presentation has ended at 1145. He has the ability to access a Live Meeting Room called a channel meetup. And these channel meetups are going to be in the community area. And the community area is where some of that networking, both asynchronous chat and virtual meetings can take place. So I'm going to head over to the community area. And you'll see here under the meetups and virtual meets tab, we have the channels already listed. So if my session was in channel one from 10, to 1145, at 1145, I can go ahead and head into this channel meetup area.

You don't need to download anything to access this area, you can simply type in your name, join the meeting, and voila, I'm in the meeting. Now we will have moderators in these channel meetups. And so the moderators role is again to make sure tech and security runs well. But also to let presenters in before attendees. One of the drawbacks of the meetup software is there is a 30 person limit in these rooms. And that is really for security reasons we selected to go with jitsi software, there's less risk of zoom bombing and outside links being shared. However, it still gives you a lot of the same options as zoom, you can share your screen, you can raise your hand, you can unmute yourself, take your video off, leave the meeting as you please. So this is going to be again that space

For open communication after the live stream presentations have taken place.



So I'm going to go ahead and leave that meeting, I'll head back to the community area. And I wanted to point out one more, one more thing. So, in this community area, you can both recommend a social topic or social group. This is for asynchronous chat. So if you want to have a topic listed here, it'll look very much like a chat area, you can type messages back and forth. Anyone in the meeting can engage in this area, and really in the chat or topic that you've posted. And the other option is the virtual meet option. So in addition to the channel meetups, again, these channels are reserved for the livestream sessions at each time slot, you can also suggest your own meetup. So if you'd like to suggest a reception a happy hour, you just like to get together with anyone who would who would want to join, you can select a virtual meet here. And then you can actually add in your own zoom account. So you can select the duration, the date and time, maybe a little title and description for the topical discussion or the happy hour that you want to host. Now all members can see this and join. So if you want to have it directed or specific for a few people, that's great. But just keep in mind that anyone can see meetups posted in this area. The other thing to note is while it's a great tool, the SFA is unable to provide moderators for these types of sessions. So if you still want to create these types of sessions, that's great. We have some instructions here.

And so this is a way to help people get a sense of your background, and what your health might be about, it's a great place to mention your name, your title, your pronouns, if that's something you feel comfortable sharing, it's also a really good opportunity to provide a visual description. And for this you can use whatever terms you feel best describe you and that you're comfortable using for yourself. You might mention things like race or skin tone, you might mention your gender,

This is also an important opportunity for you to add content warnings for any sensitive material. And so some examples of these would be violence, sexual content, human remains, basically giving people a chance to just know what to expect before you get into your session.

I know we're all moving on to considering lighting and audio. I know we're all sort of working in less than ideal conditions and this probably is not the way you are hoping to join the annual meeting. And so we're all working from home. I'm working from my bedroom right now. Like we

We get it can be very difficult to control your environment. Completely. We all have pets, we have kids. But a few, there are a few steps you can try to take.

A great thing you can do is minimizing audio distractions, whether that's through using a headset, or doing what you can to make sure you're in a quiet environment. This will help other people understand what you are saying. And to the extent possible with your setup, it's also helpful to try to minimize visual distractions, and keep the lighting in mind to help make you easier to see. So this might look like trying not to be backlit, it helps to have light in front of you.

As well as to make sure the lighting is not too harsh. But again, all of this is very difficult to control. And like not everyone has the opportunity to have the perfect video setup. I know I certainly do not.

Another thing you can do to support accessibility is to be mindful of your speaking pace. This is super important.

Especially if you're reading from a script. Because I know a lot of us have a tendency to rush through things, especially while we're presenting, you're worried about meeting our time limit. And maybe maybe we're anxious. And so it's just a great opportunity to take a moment to slow down. If you're using PowerPoint slides. It's a great idea if you're changing slides, to remember to pause in between your slides just to give yourself a little cue to take a moment to check in with your pace. You can also

be mindful about if you're reading text on a slide. This is it's great to make sure that you are providing

a description of any images.

As well as if you have text on the slide. I know we're trying to avoid not putting huge blocks of text on slides. But if you are doing that to make sure you're reading it aloud, I know that's not necessarily how we're taught to present. But this is actually really important for anyone who might not be able to see your screen. And also keeping in mind that some people will be tuning in from perhaps their phone from perhaps their tablet, the lap, even if you're just on a standard laptop screen, it's not quite the same size dimensions as you might be used to in sort of a larger conference setup. The attendee link when you sign in and create your attendee account will actually be linked with your presenter account. So if you'd prefer, you can simply log into the attendee account and create your speaker profile. From there, it's up to you, it's just a little bit easier sometimes to access it through the presenter link. So the attendee link is what's going to give you access to the entire huva events. So you'll be able to see your agenda, the community area, build out your schedule, things of that nature. Now we have some attendee guides on the SFA. website. Bear with me, I'm going to scroll back here for a second. These are going to be located under the meeting webinars have virtual meeting instructions. And under the virtual meeting instructions, we have instructions both for the desktop version and the mobile version of huva. So if you're using both, you can toggle back and forth and see instructions for signing up viewing the agenda, planning your schedule, accessing the live streams and the pre recorded videos. How do you get there? How do you interact with that area, asking questions using the huva q&a module engaging with the chat area, and then networking, so sort of takes you step by step through all of those processes.
